3. AFTER THE AUCTION

Payment

Payment must be made within 48 hours after the end of the Auction and may be made by transfer direct to Harmonie's account stated in the invoice.

Please include your name and invoice number with your instructions to your bank. Property will not be released until full payment has cleared. Harmonie does not accept credit cards as payment for purchase.

Collection and Delivery

Lots will be able to be collected by appointment Monday to Friday 10am - 5pm (excluding public holiday), and released to you or your authorized representative when full and cleared payment has been received by Harmonie.

Where you ask for us to arrange local delivery of your Lot to you, we will add charges to the final sales price in order to cover the costs of delivery and insurance. We will liaise with you regarding a suitable time for delivery but you acknowledge that delivery times cannot be guaranteed and you will make sure that the Lot can be received at the designated address on the appointed day.

Items retained will be covered by our insurance from the date of sale for a period of seven days or, if by then the goods have been collected, to the time of collection. After seven days or from the time of collection, whichever is the earlier, the lot will be entirely at the buyer's risk.

Storage and Insurance

All purchases will initially be held for collection at the saleroom at no charge. Harmonie provides insurance cover for a maximum of seven days after the sale. 
Shipping






